You have the contract

Construction work typically begins with the NOTICE TO PROCEED. The notice can be given in several ways, buy typically it is a letter directing the Contractor to begin the work.

If it is initiated by the Architect, the Notice to Proceed should be sent on behalf of the Owner and at the Owner's direction.

WHAT IT IS AND WHEN IS IT USED

- The "Notice of Award" is a short document, written by the OWNER, to inform the successful Bidder of the Owner's intent to award the contract.
 - The Note of Award establishes the beginning of "challenge period" (if any). These are periods of time during which other bidders may challenge the selection process.
- We may help and Owner to prepare the Notice of Award, but it should be issued by the Owner, not under our letterhead.

INFORMATION ON THE NOTICE OF AWARD

This is an example containing typical text. Always have the Owner to approve the Notice.

- DATE
- TO WHOM IS IT DIRECTED Legal name and address of successful bidder
- **INTENT OF AWARD**: This is to inform you that [OWNER'S LEGAL NAME] is officially warding the [COMPLETE NAME AND IDENTIFICATION OF THE PROJECT].
 - You are required to execute the Agreement and furnish the required documents, no later than [DATE] by [TIME]. If you fail to execute the Agreement and furnish the required documents by this date, the [OWNER] may consider your bid as abandoned.
- NOTICE OF PRELIMINARY CONSTRUCTION CONFERENCE: A reconstruction
 conference is schedule [DATE, PLACE, AND TIME] at the time acknowledge of receipt of
 the Notice to Proceed and written acceptance by [COMPLETE IDENTIFICATION OF THE
 SUCCESSFUL BIDDER] is received by the [OWNER].
- DATE TO PROCEED: It is anticipated that the start of the Contract Time shall be [ENTER DATE LEAVE ENOUGH TIME TO ALLOW THE BIDDER TO PREPARE FOR START OF CONSTRUCTION].
 - [OWNER] will issue the official Notice to Proceed upon the execution of the Construction Documents.

Make sure that the Owner sends out the Notice of Award.
